CALL TO ORDER

Ms. Blunk called the meeting to order at 7:00 PM with all the above-listed members present.

APPROVAL OF THE MINUTES.

The previous meeting minutes were approved.

ABR 2023-39: DANIEL SEIFRIED & ROBERT RIVERA, 2191 DELAWARE, request to alter windows.

The applicant presented plans to install a set of patio doors and two double hung windows.

Action: Mr. Saylor made a motion to approve, seconded by Mr. Wong, the motion was unanimously approved.

ABR 2023-40: BAZE LTD, 3547 SEVERN, request to construct addition.

The applicant requested approval to construct a second-floor addition to the existing 1.5 story residence. The board noted that the new siding should extend eight (8) inches above grade on the front and side of garage.

Action: Mr. Wong made a motion to approve as noted, seconded by Mr. Brooker, the motion was unanimously approved.

ABR 2023-41: MARK PERIN, 2371 WOODMERE, request to install solar panels.

The applicant requested approval to install 15 solar panels on the eastern elevation of the home, or rear garage.

Action: Mr. Wong made a motion to approve, seconded by Mr. Brooker, the motion was unanimously approved.

ABR 2023-42: BRANDON LINDROSE, 2994 CORYDON, request to request to alter windows.

The applicant presented a proposal to alter five windows on the side and rear elevations.

Action: Mr. Wong made a motion to approve, seconded by Mr. Saylor, the motion was unanimously approved.

ABR 2023-43: KHRISTI GIBSON, 3556 MEADOWBROOK, request to alter windows.

The applicant requested approval to alter windows on the front and side elevations of the home.

Action: Mr. Wong made a motion to approve, seconded by Mr. Saylor, the motion was unanimously approved.

ABR 2023-44: ALICIA HATCHER, 1545 WOOD, request to install solar panels.


The applicant requested approval to install 15 solar panels on the east roof elevation.

The meeting was adjourned at 8:30 PM


