**List of submitted questions / topics for Director of Public Works, Collette Clinkscale**

1. Dashed center line in certain sections of S. Taylor Rd.
  - a. raised as a citizen concern and appears to be in conflict with the following provision in the Ohio Revised Code (highlighted).

Section 4511.30 | Driving upon left side of roadway.

(A) No vehicle or trackless trolley shall be driven upon the left side of the roadway under the following conditions:

(1) When approaching the crest of a grade or upon a curve in the highway, where the operator's view is obstructed within such a distance as to create a hazard in the event traffic might approach from the opposite direction;

(2) When the view is obstructed upon approaching within one hundred feet of any bridge, viaduct, or tunnel;

**(3) When approaching within one hundred feet of or traversing any intersection or railroad grade crossing.**

2. Describe the timeline for different road projects, and at what stage it would be appropriate for review/feedback from TESC to be provided.
3. How are different projects prioritized, for both ongoing maintenance and larger changes to roadways? For example, is there a specific time frame the city follows for repaving / restriping? How are safety concerns integrated into the design and planning of larger projects to improve multimodal transportation?
4. Signalized Pedestrian Crossings: what is involved with programming the lights (e.g., the length of crossing intervals, whether lights actuate from certain directions)?
5. Sidewalk Repairs and Code Violations
6. Some low hanging fruit:
  - a. Accessible Parking at Amplify(medical business)
  - b. Overlook and Kenilworth traffic light going west on Kenilworth obscured by trees
  - c. No beat cops on Coventry. Parking is a free for all. Crosswalks, middle of the road.
  - d. White supremacy and anti trans graffiti on sidewalks
