## CR-05 - Goals and Outcomes

### **Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)**

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

The City of Cleveland Heights bases the development of its Community Development Block Grant (CDBG) Program on the National Objectives and the Primary Goals established by the U.S. Department of Housing and Urban Development for the CDBG Program and upon the needs established in the City's Five-Year Consolidated Plan. Each year the City, in conjunction with its twenty-two-member Citizens Advisory Committee, reviews the community's CDBG Goals and Objectives.

The 2024, PR-26 for CDBG reflects adjustments made to account for \$207,387.18 in eligible CDBG expenditures made in 2024 but not drawndown until 2025. This affects the calculation for the proportion of program funds spent low and moderate-incomeThe City of Cleveland Heights' CDBG Certification with HUD specifies that we will give maximum priority to activities that benefit low- and moderate-income persons, specifying that the aggregate use of CDBG funds during program years 2023, 2024, and 2025 shall be a minimum of 70% of our expenditure. In 2024, \$1,214,188.66 or 83.5% of our expenditures were on activities benefiting low- and moderate-income (LMI) persons. For both 2023 and 2024, \$2,493,327.41 was expended on low- and moderate-income persons representing 83.9% of program spending.

Having prioritized the National Objectives of the CDBG program in our Goals and Objectives, we have focused as a community on providing funds to activities that benefit low- and moderate-income persons and eliminates slum and blighted conditions. Slum and blighted conditions within the City have been identified through the Investment Target Area (ITA) study last updated in 2012. The City also addressed slum and blight on a spot basis, determining eligibility by using the adopted ITA definition of slum and blight.

Below is a summary of the City of Cleveland Heights' Local Goals.

**Goal I: Improve, Maintain, and Expand Affordable Housing:** provide programs for renters and owners, including down-payment assistance, home improvement, weatherization/energy efficiency, accessibility improvements, and correction of building code violations. Eligible areas will receive housing code enforcement services.

**Goal II: Revitalize Residential Neighborhoods:** improve the physical condition, health, and safety of neighborhoods with projects such as improvements to rights-of-way, water and/or sewer lines, and/or public facilities. The City may also fund activities to remediate blighted

conditions.

Goal III: Provide Needed Public Services: focus on the elderly, frail elderly, persons with physical disabilities, persons with developmental disabilities, and low- and moderate-income families with children to improve access to needed public services that improve household stability and educational, work, transportation, healthcare, housing and healthy food access. The City will also assist public service activities on issues such as – but may not be limited to – youth, diversity, food assistance, homebuyer/foreclosure counseling, and fair housing.

Goal IV: Increase Economic Opportunities: provide public infrastructure improvements to aid economic development; assist for-profit commercial enterprises with access to working capital, building rehabilitation and new construction activities designed to create or retain jobs; eliminate substandard or blighted buildings and neighborhood conditions.

**Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.**

Goal I: \$776,927.84 or 42.3% of 2024 CDBG expenditures were spent on housing programs. The following programs meet Goal I: HPO Program Delivery, Home Repair Program, Sheior Home Repair Program, HRRC Program Delivery Costs, ASSIST Incentive Grants, Senior Home Stability Grant, Major Systems Deferred Loan Match Program, HRRC Housing Counselor, Start Right CDC Good Neighbor Program and the FutureHomes Program.

Goal II: In 2024, \$277,927.90 or 15.1% of the total CDBG expenditures was used for this objective. The following programs meet Goal II: the Nuisance Abatement Program, HPO Program Delivery Costs (Slum & Blight), LMI Code Enforcement, and the Annual Streets Improvement Program.

Goal III: In 2024, \$220,757.15 or 12.0% of CDBG funds were expended on public services activities representing 11% of total CDBG spending. The following programs meet Goal III: Office on Aging, Heights Emergency Food Center, Start Right CDC Food Program, Gesher, Open Doors Academy, Family Connections, Lake Erie Ink, Naaleh Cleveland and WAVE Mentoring Program.

Goal IV: In 2024, \$222,000.19, or 12.1% of CDBG was expended on Goal IV. The following programs meet Goal IV: Storefront Renovation Rebate Program - S/B, Storefront Renovation Loan Program - S/B, Commercial Revolving Loan Program, and Economic Development Program Delivery Costs.

**ADMIN, PLANNING AND FAIR HOUSING ACTIVITIES:** In 2024, \$339,749.22 or 18.5% of CDBG was expended on admin activities. The following acitivities fall under the category of administration, planning and fair housing: CDBG Administration; the North Coventry Planning Project; Fair Housing activities; and FutureHeights Community Capacity Building.

The vast majority of activities are open to all areas of Cleveland Heights. Some programs that are classified as low-mod area benefit are limited to low-mod areas.

## Leveraging

**Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.**

Cleveland Heights has been successful in leveraging additional funds. Many of the City's rehabilitation programs require the homeowner to match the funds they receive. HRRC and FutureHeights have established good working relationships with three area banks that contribute to their ability to leverage additional funds. During the past year, CDBG housing rehab activities leveraged \$75,173.00 in private funds. In 2024, the Storefront Renovation program leveraged \$9,728.55 in private funds. Lastly, the Commercial Revolving Loan Program leveraged \$35,750 in private and foundation funds.

**Discuss the difference between goals and outcomes and problems encountered in meeting these goals.**

Actual outcomes exceeded projected goals for 2024. This is despite adjusting program maximum subsidies in order to complete larger projects like roofs and waterproofing. This can be partially explained by the availability of additional rehab funds through City and State ARPA funds that allow more projects to move forward due to less reliance on homeowner financial contributions. Additional outcomes from projects that began in 2024 but will not be finished and expensed until 2024 will appear in 2025's outcomes.

## Discuss how these outcomes will impact future annual action plans.

We believe these trends will continue through 2026, when ARPA funding will have been exhausted. The City is also working with affordable housing providers TWG and National Church Residences to construct new affordable housing in Cleveland Heights on and formerly owned by the City. TWG broke ground on a 52-unit affordable housing development in 2024. National Church Residences intends on constructing a 71-unit affordable senior development in 2026. Both of these projects intend on utilizing both HOME and LIHTC funds.

## Narrative Information

The housing programs funded with CDBG, HOME and Lead Safe Cuyahoga funds assist low- and moderate-income homeowners with the rehabilitation of their homes. These programs directly assist low- and moderate-income homeowners to maintain their homes through activities such as below market interest rate rehabilitation loans, an exterior paint program grant and providing services to the elderly and disabled that assist them to remain in their homes. Non-CDBG HUD-funded programs assisted an additional 12 buildings representing 25 households in 2024.

The City has determined that our area of greatest need is that of owner-occupied housing. We are a community with a wide variety of housing opportunities including: apartment buildings, modest single-family homes, two-family homes, medium priced to very high-end single-family homes and condominiums. Most of our housing was built prior to 1945 and therefore home repairs can be a barrier to low- and moderate-income homeowners. Housing rehabilitation costs are barriers that we are addressing to assist low- and moderate-income households remain in their homes.

Additionally, high property tax rates, due largely to the method of public-school funding in the State of Ohio, creates an additional cost burden on all households, particularly low- and moderate-income households.

In 2024, 137 low- and moderate-income households were assisted to maintain their affordable homes through the CDBG, HOME and Lead Safe Cuyahoga rehabilitation programs.

The City has a goal of assisting low- and moderate-income homebuyers. To that end, the City of Cleveland Heights utilized HOME funds to assist low- and moderate-income households purchase homes. HRRC manages this program for Cleveland Heights. HRRC is reimbursed up to \$500 for direct program management costs and up to \$500 for housing counseling services for each completed down payment loan. The program provides up to \$10,000 of down payment assistance for single-family homes. The homebuyer must provide 3.5% of the sale price from personal funds. In 2023, 2 LMI homebuyers participated in the down payment assistance program. This small number is largely due to the prevalence of cash transactions and the proliferation of non-FHA loans due to their lack of home inspection requirements. In 2025, the City and HRRC will transition to using ARPA funds for its Down Payment Assistance Program. This influx of federal funds will help increase the subsidy limit to \$30,000 per unit.

Cleveland Heights worked with HRRC to become a HUD Certified Housing Counseling Agency several years ago. The City helps fund this activity with CDBG dollars.

The City of Cleveland Heights is not a recipient of ESG or HOPWA funds. Cuyahoga County oversees homeless interventions in Cleveland Heights.

**Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs**

The City of Cleveland Heights is not a recipient of ESG or HOPWA funds. Cuyahoga County oversees homeless interventions in Cleveland Heights. The City does work with the Home Repair Resource Center by providing housing counseling and by assisting homeowners maintain a safe and sanitary home.

**Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again**

The City of Cleveland Heights is not a recipient of ESG or HOPWA funds. Cuyahoga County oversees homeless interventions in Cleveland Heights. The City is however working with a local service provider for young adults who have aged-out of the foster system to rehabilitate an 8-unit apartment building utilizing HOME funds. This project will both house and offer services to this target population that is at a high-risk for being unsheltered. .

## **CR-30 - Public Housing 91.220(h); 91.320(j)**

### **Actions taken to address the needs of public housing**

The City of Cleveland Heights in partnership with the Cuyahoga County Department of Development and the HOME Consortium work with affordable housing providers to develop and rehabilitate multi-unit buildings. Additionally, the City has recently worked with the Severance Tower Local Advisory Council and the Cleveland Metropolitan Housing Authority to replace an inaccessible community garden with a fully accessible community garden and gathering space.

Activities with a Low-Mod Area benefit, activities with a presumed benefit, and public service activities affect the residents of public housing facilities and improve the viability of public housing facilities through improved livability and access to community resources and infrastructure.

The City is also working with affordable housing providers TWG and National Church Residences to construct new affordable housing in Cleveland Heights on land formerly owned by the City. TWG broke ground on a 52-unit affordable housing development in 2024. National Church Residences intends on constructing a 71-unit affordable senior development in 2026. Both of these projects intend on utilizing both HOME and LIHTC funds.

### **Actions taken to encourage public housing residents to become more involved in management and participate in homeownership**

The City works with a local CDC, FutureHeights, to encourage civic participation by residents throughout the City primarily through a leadership course. FutureHeights and the City have prioritized residents from underrepresented groups, particularly residents of public housing, to participate in their programming. Additionally, the City and the County both fund HUD-Certified Housing Counseling Agencies in order to encourage homeownership and to educate public housing residents in homeownership. The City utilizes HOME funds and ARPA funds to provide Down Payment Assistance to LMI households.

### **Actions taken to provide assistance to troubled PHAs**

The City participates in the Cuyahoga Affordable Housing Coalition along with the Cleveland HUD Field Office. There were no identified troubled PHA's in Cleveland Heights in 2024.

### **CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)**

**Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)**

The City's Zoning Ordinance was revised and an amending ordinance was proposed in 2017. The revised ordinance was passed by Cleveland Heights City Council on January 16, 2018. This ordinance redefined "Family" in the City's zoning code. The change functionally removes barriers to non-traditional families and group living situations to locating in non multi-family zoning districts. Additionally, in 2018, the City implemented a city-wide property tax abatement program. The tax abatement benefits of the program change based on the location of the property. Properties located in distressed or underperforming Census Block Groups receive greater benefits. Low-Mod Area Eligibility is one of several factors that increase the term or amount of property taxes abated.

In 2024, the City completed a Accessory Dwelling Unit study to explore the possibility of allowing this type of housing in the City's Zoning Code, greatly expanding the amount of housing affordable to low, moderate and middle income households. The study has received positive feedback and the City intends to pursue this change in 2025.

### **Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)**

Due to the unanticipated increase in CDBG funding for FY 2018, the City instituted a Strategic Impact Opportunity that targets historically underserved neighborhoods for CDBG eligible projects. This program has continued through 2023. Housing rehabilitation assistance to non-disabled and non-elderly homeowners increased as a result of this. Additionally, the City along with several partners is undergoing comprehensive planning studies for both the Noble Road Corridor, the South Taylor Corridor, and the designated RECAP neighborhood of North Coventry.. All of these studies seek to improve the livability of historically underserved sections of the City. Lastly, through the Anaysis of Impediments process, the City identified that renters facing eviction do not have adequate access to legal resources. The City and County began offering legal advice and legal representation to help prevent unnecessary evictions.

### **Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)**

Cleveland Heights continues to provide educational materials on lead-based paint to each homeowner and tenant whose property is undergoing rehabilitation. All City of Cleveland Heights departments involved in the purchase, renovation, or sale of housing have been informed of the single-family and multi-family disclosure for lead paint that took effect in Fall 1996.

The City of Cleveland Heights has been working with the Cuyahoga County Department of Development

to implement a three-year lead-based paint hazard identification and reduction program that was funded by HUD. In 2024, the City of Cleveland Heights assisted 25 low- and moderate-income households with children under the age of six to remove lead paint hazards from their homes. This program will continue through 2024 utilizing Lead Safe Ohio funds provided by the State of Ohio.

The City of Cleveland Heights has also passed a lead safe rental registry program that requires all landlords, over a multi-year phased approach, to pass a lead clearance test on each of their rental units in order to receive a required rental registration. Through ARPA, the City will be continuing to assist landlords to meet this requirement. Additionally, through State ARPA funds, the City helped childcare facilities remediate lead based paint hazards.

#### **Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)**

Cleveland Heights utilizes CDBG funds to support public services that have an impact on poverty. CDBG funds provide support to the Heights Emergency Food Center and Start Right CDC Hunger Center, which provide very low-income families a three-day supply of food once a month. 11,069 households were assisted in 2023.

The City's HPO and HRRC (a HUD certified counseling agency), provide counseling to low- and moderate-income homeowners. The counseling includes financial management of a household budget, which assists those persons having few financial means.

All of the City's housing programs are geared to assist persons of low- and moderate-income homeowners. We are fortunate to be a community with a wide variety of housing choices including: apartment buildings, modest single-family homes, two-family homes, medium priced to very high-end single-family homes and condominiums. Most of our housing was built prior to 1945 and therefore home repairs can be a barrier to low- and moderate-income homeowners. Housing rehabilitation costs are barriers that we are addressing to assist low- and moderate-income households remain in their homes.

#### **Actions taken to develop institutional structure. 91.220(k); 91.320(j)**

The City of Cleveland Heights continues to work to overcome gaps in institutional structure and enhance coordination. This effort includes the participation on numerous boards and committees. Staff serves on the First Suburbs' committees addressing housing, economic development and community services to discuss common issues and approaches to addressing issues and creating opportunities. Staff works with the Cleveland Heights' Family-to-Family Collaborative that works to strengthen support to families. Cleveland Heights is an active member of the Cuyahoga County HOME Consortium. Staff serves on the Executive Committee of the Greater Cleveland Reinvestment Coalition. The City of Cleveland Heights actively seeks opportunities to enhance services and coordination. We look to all of our partner agencies as well as our current subrecipients and the public to assist with our comprehensive planning for our programs.

**Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)**

The City is an active member in the Greater Cleveland Reinvestment Coalition, a coalition of municipalities and housing agencies that focuses on bank performance in regard to the CRA. Through these monthly meetings, participants often share knowledge and expertise in order to better serve their constituents. The City also participates in the Cuyahoga Affordable Housing Alliance and the First Suburbs Housing Committee with similar benefits. The City also participates in the Heights Collaborative, a collaborative that focuses on the foster care system. Similar networking and benchmarking activities take place that improve service delivery in regards to social services.

**Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)**

The City of Cleveland Heights is committed to fair housing. The City has staff that work to encourage fair housing and has established a Fair Housing Board which is charged with the following duties:

- To investigate all complaints which are filed with it pertaining to discrimination in housing;
- To endeavor by conciliation to resolve complaints when appropriate; and
- To recommend action to be taken through local, state and federal court.

In 2014 the City expanded the role and jurisdiction of the Fair Housing Board (now called the Fair Practices Board) to hear and investigate complaints concerning discrimination in places of public accommodation as well as in a housing context.

The City of Cleveland Heights completed an update to our *Analysis of Impediments to Fair Housing Choice* in 2020. This document was produced in partnership with the Fair Housing Center for Rights and Research. The observations collected during the development of the AI constitute the potential impediments or barriers to fair housing choice listed in this section. These impediments are linked to remedial strategies in the Fair Housing Action Plan.

**1. Impediment: The City of Cleveland Heights Has Limited Accessible Housing Options for People with Disabilities**

The City makes housing rehab funds available specifically for the elderly and people with disabilities. The City, by encouraging new construction, particularly multi-family housing, is gradually adding more accessible units to the City's housing stock. Additionally, the City's partner, HRRC, has also implemented an aging in place program that invests in the accessibility of a home. The City has also implemented a Complete and Green Streets Policy that emphasizes accessibility in public spaces. Additionally, the City continues to enforce the Americans With Disabilities Act (ADA) through the building permit process and

public facility investment.

*2. Impediment: The City of Cleveland Heights' Fair Housing Ordinance does not Protect Housing Voucher Program Participants*

Legislation was passed on April 19, 2021 adding Source of Income to the City's fair housing ordinance (Ord. 25-2021). In 2022, our Fair Housing Partner, the Heights Community Congress, worked to notify landlords of this addition. Heights Community Congress also monitor rental property advertising for violations of this ordinance.

*3. Impediment: Criminal Activity Nuisance Ordinance*

In 2024, the City continued to monitor the City's CANO implementation in order to remove any policies that may prove discriminatory.

*4. Impediment: Low-income residents of Cleveland Heights are displaced by eviction and housing costs.*

The Legal Aid Society of Cleveland continued their eviction prevention efforts in Cleveland Heights, which included counseling, education and legal representation. The City has added additional funding to this program in order to boost resources to Cleveland Heights residents facing eviction.

## **CR-40 - Monitoring 91.220 and 91.230**

**Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements**

The Cuyahoga County HOME Consortium adopted a performance measure to track during 2015:

The number of housing units assisted that have eliminated at least one significant health and safety deficiency as a result of housing rehabilitation, as defined by local codes.

All of Cleveland Heights' housing programs tracked this performance measure. During 2023, 86 housing units assisted by the City of Cleveland Heights' housing programs eliminated at least one significant health and safety deficiency.

The CAC and City staff continue to work with local CDBG recipients to establish effective performance measurements. This information is required of all applicants seeking CDBG funds. The City of Cleveland Heights has locally adopted goals and objectives for our CDBG program. The outcome measurements attempt to demonstrate our achievement in reaching the stated goals. The CAPER narrative describes the activities conducted to address each goal and provide output information. All CDBG recipients are reporting outcomes based upon HUD's outcome reporting requirements.

The CDBG and HOME programs significantly assist the City of Cleveland Heights to address neighborhood and community issues. These programs help the city to achieve the overall goal of ensuring the availability of decent housing and a suitable living environment for all Cleveland Heights residents, and of expanding economic opportunities for persons of low- and moderate-income. We will continue to use the funds provided to us to assist those in greatest need in Cleveland Heights. The City's rigorous systematic exterior inspection program is reporting less housing with serious housing violations. Businesses continue to be interested in and choose to locate in our commercial business districts. Developers are interested in constructing new housing on infill lots and through larger developments of assembled land. These outcomes are the results of the strong CDBG and HOME activities described in this CAPER. In summary, the City of Cleveland Heights continues to strive to meet and exceed our goals and objectives to assist low- and moderate-income households and to address slum and blight to maintain a viable community through the efficient management of CDBG and HOME resources.

## **Citizen Participation Plan 91.105(d); 91.115(d)**

### **Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.**

In 1978, the City of Cleveland Heights developed a committee to provide citizen input on a timely and regular basis. Our Citizens Advisory Committee (CAC) consists of twenty-two members representing each of the twelve distinct neighborhoods of the city as well as ten at-large members, all appointed by City Council for one-year terms. The CAC holds public meetings each month to review CDBG activities. CAC holds two public hearings each August to allow subrecipients and City staff an opportunity to report on how they spent their CDBG funds and for agencies that wish to be considered for funding in the following year to present their proposals. Each September, CAC holds two public deliberation sessions regarding funding recommendations and each October/November a public hearing is held to review the annual plan. During its work sessions in September and October of 2024, the CAC made recommendations on the funding of organizations for Year 51. Minutes of all CAC meetings are available for further review upon request. A copy of the Citizen Participation Plan and definition for Significant Change are attached. This plan was updated during the second quarter of 2020 and adopted by City Council.

Realizing the importance of decent housing, a suitable living environment, and the need for economic opportunities for LMI residents, the City of Cleveland Heights adopted updated goals with the submission of the 2020-2024 5-Year Consolidated Plan.

City Council and the CAC believe that CDBG funds should be used in a manner that provides direct benefits to low- and moderate-income persons. This is reflected in the percent budgeted and expended on LMI activities in 2024.

A copy of this document, the Consolidated Annual Performance and Evaluation Report (CAPER), was made available for public comment from March 16, 2024 through March 30, 2024. A legal notice was placed in our local newspaper, The Sun Press, on March 13, 2025 notifying the public of the availability of the CAPER for review and comment.


