

As a member of City Council, my role would be to serve as a bridge between residents and city government while setting clear policy direction and ensuring accountability. My priorities would focus on public safety rooted in prevention and trust, economic development that supports local businesses and job creation, youth development and workforce readiness, equitable infrastructure investment, and transparent government that communicates clearly and measures results. I believe the City can improve in coordinating efforts across departments, using data more effectively to evaluate programs and spending, expanding access to opportunity in underserved neighborhoods, and engaging residents more consistently in decision-making. My service on City Council would help achieve these goals by bringing a coaching and development mindset to leadership, applying my legal and governance experience to strengthen oversight and fiscal

responsibility, and building strong partnerships across public, private, and nonprofit sectors to deliver long-term, measurable impact for the community.

I bring a combination of legal training, executive leadership experience, and a coaching mindset that focuses on developing people, strengthening systems, and achieving measurable results. My background in law, governance, and nonprofit and public-sector leadership allows me to analyze policy critically, ask the right questions, and ensure decisions are fiscally responsible, equitable, and aligned with long-term community goals. I also bring strong facilitation and listening skills, enabling me to engage residents with differing perspectives and build consensus without losing focus on outcomes. I have working knowledge of City Council meetings, including agenda setting, committee structures, legislation review, public comment, voting procedures, and the importance of open meetings and transparency. This combination of practical governance experience, collaborative leadership, and accountability-driven decision-making would add immediate value to Cleveland Heights City Council and help strengthen trust between residents and city leadership.

My formal education includes a Juris Doctor, with executive leadership training through a nationally recognized management program, and undergraduate studies in political science, all of which strengthened my ability to analyze policy, understand governance structures, and lead with discipline and accountability. city departments, and community stakeholders to design, implement, and evaluate programs. Informally, my experience coaching leaders, mentoring youth, facilitating community conversations, and working directly with residents across diverse neighborhoods has sharpened my listening skills, judgment, and ability to translate community needs into actionable solutions.
