Thank you for reaching out.

Attached is the Scope of Work, Performance Guarantee, and the Measurement and Verification Plan for the project.

I appreciate the willingness of the Committee members to help with the project. I have often emphasized in my engagement sessions with the community and in academia, that it takes a village to build resilience to climate change and its impacts.

As previously communicated to the Committee and also stated in the City's Climate Action and Resilience Plan, the City completed a process of identifying metrics(such as electricity and natural gas savings, energy intensity and carbon emissions reduction)based on which this energy efficiency improvement project was initiated.

This positions the City to meet its carbon mitigation goal of a 30% reduction by 2030(per Resolution 622021 adopted in May of 2021). This step was completed prior to the issuance of the RFQ for the identification, design and implementation of energy efficiency improvements of our buildings and facilities on a self-funding performance contracting basis in accordance with Ohio Revised Code 717.02.

A rigorous scientific process of reviewing Statements of Qualifications from well-qualified Energy Service Companies(ESCOs), and subsequent selection was made by a team of experts drawn from varied backgrounds.

Thank you again for your outreach. If the committee's involvement becomes necessary at any stage of the project, we will reach out accordingly.
