

I have an outgoing personality and that makes it easy for me to engage with community members, host events, and do the work necessary to ensure that the city residents feel heard and our policy reflects what is both feasible and necessary.

I have sat in on City Council meetings in both Cleveland and Bedford Heights in the past. I am aware of the general flow of the meetings and the roles of each member typically. I am fortunate that my career choices have given me extensive knowledge in many areas.

Finance- I operated the finance and budgeting of a multi million dollar agency for individuals with developmental disabilities from 2020-2022. I then did this as a consultant for a large agency in Cuyahoga County before opening my own DODD agency in 2023. This agency has successfully grown to over 2 million dollars in revenue in the 2 years we have been open. I have secured grants, managed our payroll, taxes, and annual budget

Advocacy- My role at MIM Software grew very quickly as my skills were needed and appreciated. Today that Cleveland based company has been acquired by GE. Throughout the 7 years that I was there, I created the framework for the roles that the company has now, I built policy and procedures for hiring, promotions, product development, and client interaction. I have significant skill in assessing a company, process, or situation and determining

where the bottlenecks or weak points may be. After identifying this, I create a roadmap that will allow for improvement

Collaboration- Working in tech as a manager and with many businesses I have refined my skills in leadership. Leadership may look different depending upon the room I'm in, but effective leadership has the same tenets. ground- I used my experience in tech to successfully market my businesses, train and recruit staff, and improve my programming and employee experiences. I have extensive experience in working with small business owners and in 2022 I began teaching other entrepreneurs how to open and run their own DODD agencies through a series of classes over 6 weeks. I believe I have listed the experiences that reflect my skills above.

Currently provide after school programming to over 90 children ages 5-17 and this number is expected to double before the end of the first quarter.

Organized and funded a "Back to School" event in Cleveland which occurred on 8/16/25. We recruited other local businesses which were able to showcase their unique offerings. We donated over 400 bookbags to families in need, provided free haircuts, braiding services for young girls, food, and information on upcoming after school programs

In May of 2025 I began operation of a summer camp/respice services for underserved youth in Cuyahoga and Lake County. We successfully served over 70 children at no cost to them 4 days a week and provided healthy meals along with field trips 3 out of 4 days each week. This led to the current after school programming which I offer and partner with various businesses in the county to provide tutoring, mentorship, STEM training, sports conditioning, and fun group activities.

As a member of a non profit which helped minority businesses in Cleveland with staffing, marketing, and business efficiency, I hosted entrepreneurial classes for Warrensville Heights High School monthly for the 2022-2023 school

During the summer I do enjoy engaging with our Summer Camp and this is typically complete by 3pm on any days that I pop in on the camp attendees.

My life goals and worldviews are that of an advocate. This can be seen in the various mothers whose children receive services from me and then request I sit in on teacher meetings or help navigate difficult situations. I apply the same advocacy to the healthcare that our elderly, disabled, and children receive by routinely attending appointments, reviewing medical charts, and helping with referrals to ensure their needs are being met. I have a unique connectedness to community work that was instilled upon me by my grandmother and parents who were teachers and activists. I ensure that the youth I'm able to serve learn how to use their voices in our complex world and I am a voice for those in need.

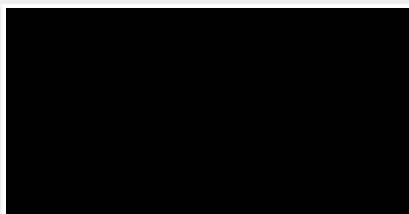
