

RESOLUTION NO. 20-2020 (PSH)

A Resolution amending Resolution No. 113-2019 to eliminate possible ambiguity regarding issuance of on-street parking permits on portions of Overlook Road; and declaring an emergency.

WHEREAS, Section 351.09 of Part Three (Traffic Code) of the Codified Ordinances of the City of Cleveland Heights prohibits, with the exception of a physician making an emergency call, parking of any vehicles on any street in the City of Cleveland Heights between the hours of 3:00 a.m. and 6:00 a.m.; and

WHEREAS, pursuant to Resolution No. 113-2019, this Council determined there to be insufficient off-street parking for residents and guests of certain streets and authorized the City Manager to issue parking permits allowing all-night, on-street parking on various streets within the City; and

WHEREAS, this Council wishes to eliminate possible ambiguity concerning the issuance of on-street parking permits on sections of Overlook Road; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Cleveland Heights, Ohio, that:

SECTION 1. Resolution No. 113-2019 is hereby amended to henceforth read as follows:

SECTION 3. The City Manager is additionally authorized to issue permits to residents and owners of property on Hampshire Road and Overlook Road to park overnight on the area between Hampshire Lane and Overlook Road at Euclid Heights Boulevard and on the east side of Overlook Road from south of the Edgehill Road intersection in front of PPN 685-03-057 to the northern driveway of 2300 Overlook Road, PPN 685-02-002. Such permits shall be available for sale from January 1, 2020, through December 31, 2020, at a cost of One Hundred Fifteen Dollars (\$115.00) per calendar quarter.

SECTION 2. All remaining provisions of Resolution No. 113-2019 shall remain in full force and effect.

SECTION 3. Notice of the passage of this Resolution shall be given by publishing the title and abstract of contents, prepared by the Director of Law, once in one newspaper of general circulation in the City of Cleveland Heights.

SECTION 4. This Resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health and safety of the inhabitants of the City of Cleveland Heights, such emergency being the necessity of eliminating possible ambiguity at the earliest time possible to allow the above-described regulation to take effect at the

earliest time possible to alleviate current parking conditions. Wherefore, provided it receives the affirmative vote of five (5) or more of the members elected or appointed to this Council, this Resolution shall take effect and be in force immediately upon its passage; otherwise, it shall take effect and be in force from and after the earliest time allowed by law.
